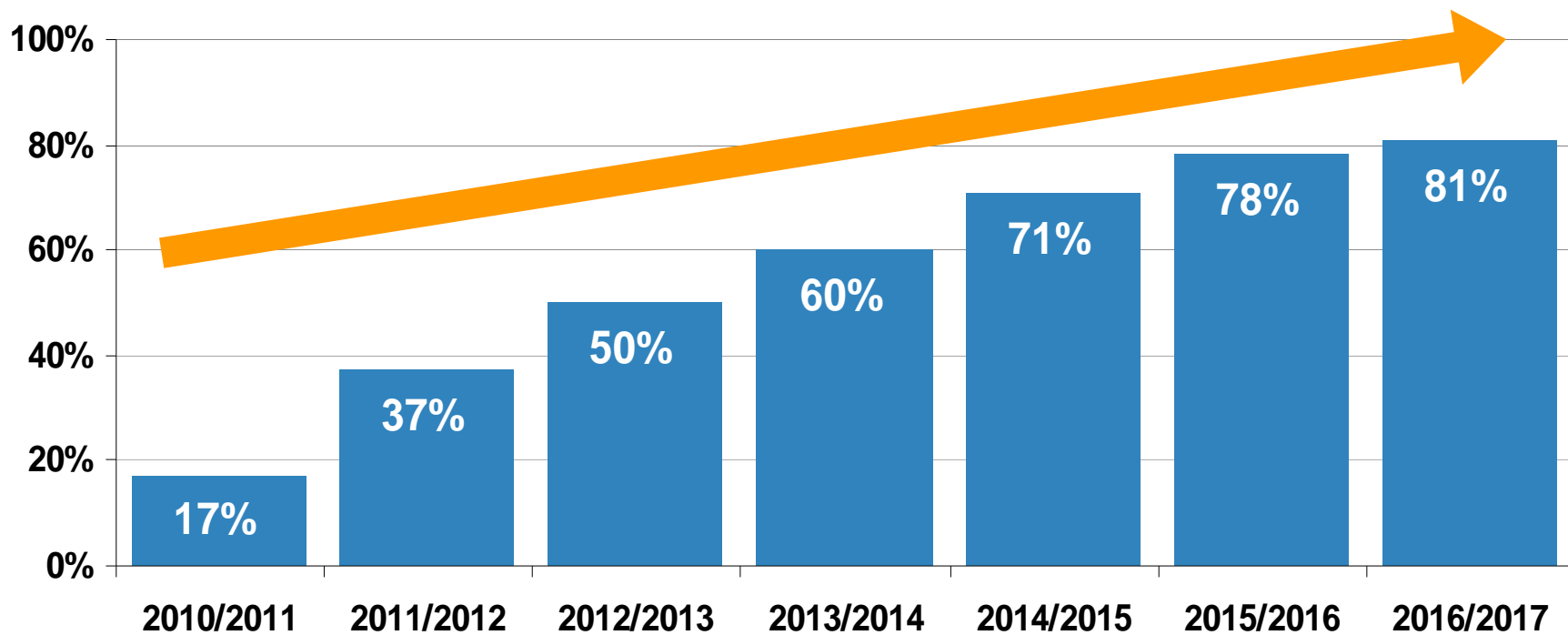

the uncertainty of the timing and amounts of the capital expenditures that may arise in connection with any litigation, including New Source Review litigation or potential regulatory initiatives or rulemakings (including that such expenditures could result in our decision to deactivate or idle certain generating units); the uncertainties associated with the deactivation of certain older regulated and competitive fossil units including the decision to deactivate the Hatfield's Ferry and Mitchell Power Stations, the impact on vendor commitments, and the timing thereof as they relate to, among other things, Reliability Must-Run arrangements and the reliability of the transmission grid; adverse regulatory or legal decisions and outcomes with respect to our nuclear operations (including, but not limited to the revocation or non-renewal of necessary licenses, approvals or operating permits by the Nuclear Regulatory Commission or as a result of the incident at Japan's Fukushima Daiichi Nuclear Plant); issues arising from the indications of cracking in the shield building at Davis-Besse; adverse legal decisions and outcomes related to Metropolitan Edison Company's and Pennsylvania Electric Company's ability to recover certain transmission costs through their Transmission Service Charge riders; Percent of PJM Installed Reserve Requirement Met by Demand Response, Energy Efficiency and Imports

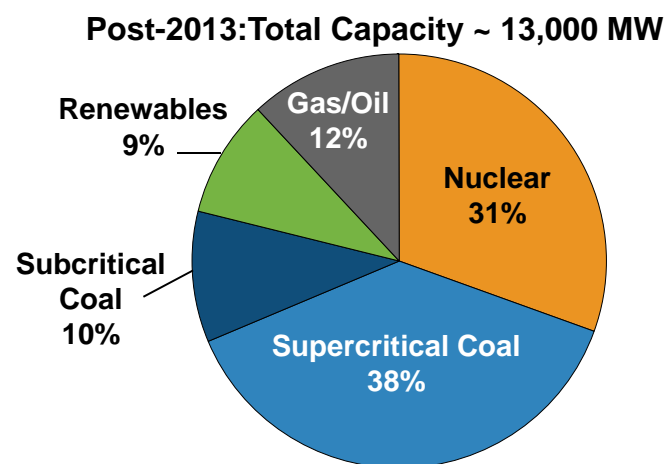
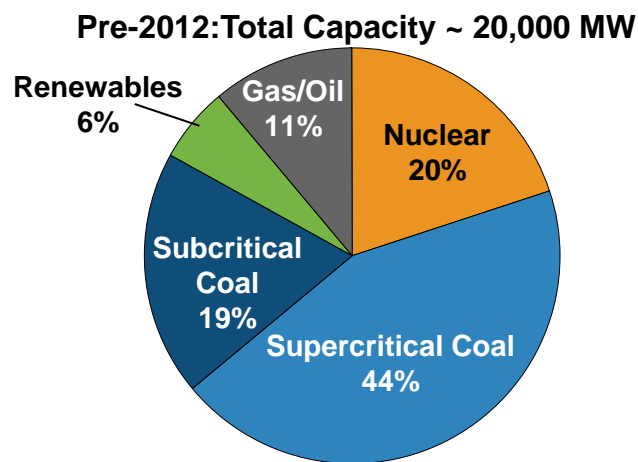

■ Repositioned our competitive business

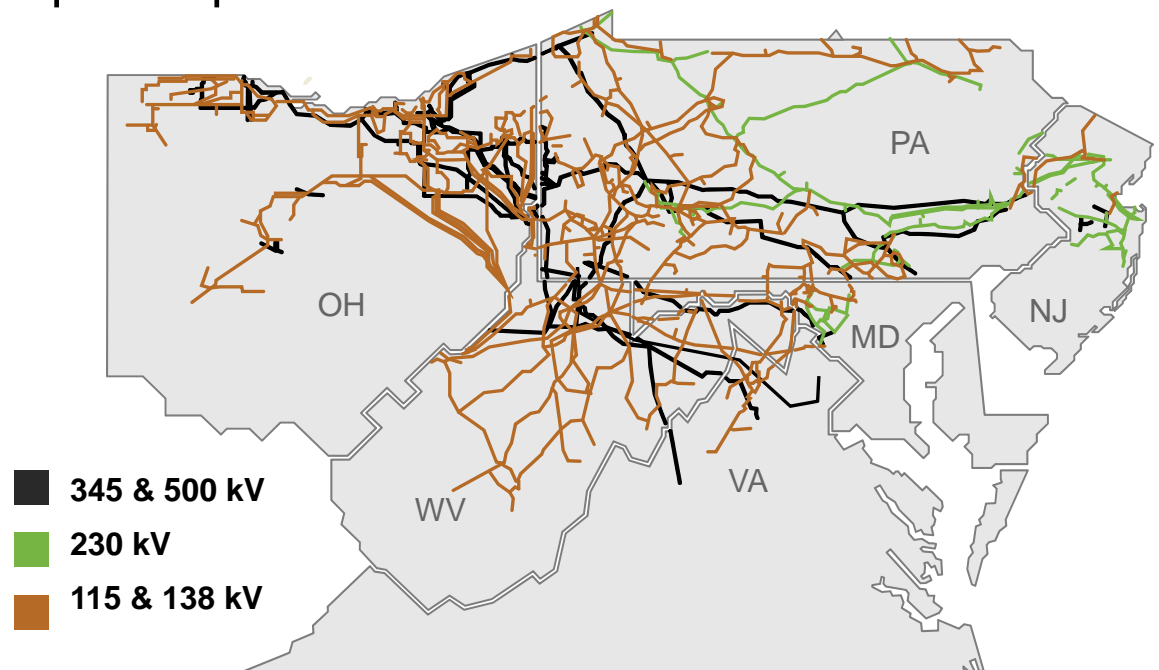
- Reduced size of generation fleet and shifted mix of assets
 - Deactivations in 2012 and 2013
 - Proposed transfer of Harrison/Pleasants and sale of certain hydro assets (527 MW – \$400M)
- Reduced capital expenditures by \$875M
 - Majority of 2014-2017 capital dedicated to nuclear
- Significantly improved credit metrics
 - +\$1.5B debt reduction at FES/AE Supply
